THIS DEED, made this 2 day of October, 2017, between the UNITED STATES OF AMERICA, "GRANTOR", acting herein by and through the Forest Service, United States Department of Agriculture, pursuant to the Camp Elim/Long Meadow Ranch Land Exchange Joint Venture Exchange Agreement, dated September 13, 2017, and COLORADO ROCKIES BIBLE CAMP AND CONFERENCE, INC., a Colorado nonprofit corporation, whose address is 5567 Painted Rocks Road, Woodland Park, Colorado 80863, "GRANTEE".

WITNESSETH: That the Grantor, hereunto pursuant to the Weeks Act of March 1, 1911 as amended (16 U.S.C. 516 et seq.); General Exchange Act of March 20, 1922 (42 Stat. 465, as amended; 16 U.S.C. 485, 486); Federal Land Policy and Management Act of October 21, 1976 (90 Stat 2743, 43 U.S.C. 1716, 1717); Federal Land Exchange Facilitation Act of August 20, 1983 (102 Stat. 1086; 43 U.S.C. 1716 (note)), the provisions of which have been complied with, for, and in consideration of a proportionate and equivalent value of certain non-Federal lands in Douglas, Teller and El Paso Counties, Colorado, containing 176.229 acres, more or less, and/or cash equalization value by the United States of America, in order to equalize values pursuant to Section 206(b) of the Federal Land Policy and Management Act of 1976 (43 U.S.C., 1716), distributed in accordance with the terms of the Camp Elim/Long Meadow Land Exchange Joint Venture Exchange Agreement, the receipt and sufficiency of which is hereby acknowledged, does hereby REMISE, RELEASE, AND QUITCLAIM unto the said GRANTEE and its assigns all the following described real estate in the County of Teller, State of Colorado, to wit:

The Grantee, its heirs and assigns, shall indemnify, defend and hold the United States of America, its various agencies and/or employees, harmless from any damage, loss, claims, liability and costs resulting in any way from activities, past, present or future, by any entity, on the above described property, specifically including but not necessarily limited to, those activities by which potentially hazardous substances, pollutants, or contaminants, or hazardous wastes, as defined by federal or state environmental laws were stored, used or otherwise disposed on the above-described property, and any
